**Committees:**

- Protocols (Report by Brenda): Dr. Lightfoot's name will be updated on the Protocol cover.
  - Blood sugar: Protocol to be updated that EMR's can check blood sugar if training records show they have been trained to do so.
  - SGA: iGel or King is allowed. Agency's must choose which one they will choose, can't use both.
  - ASA: Dose has been increased to 324mg to match Dispatch EMD protocols.
  - CPAP: some wording changes to indications and contraindications are being made.
  - Pre-impregnated combat gauze has been approved to be placed in BLS protocols.
  - Removal of prone position for restrained patients.
  - Whitcom will dispatch death in need of confirmation as Omega.

- Stroke: If time since last normal is close to 4.5hrs, contact medical control for guidance on destination hospital.
- Brenda will update protocols and Marv will make sure they get online when he receives them.

**Old Business:** EMT class update: Jamie gave a report that the spring EMT class is going well and almost half way over.

**New Business:** Jonus Landsrom from Airlift NW was in attendance and shared the services provided by Airlift NW. Airlift NW is currently able to provide secondary services from Yakima with both fixed wing and rotary. Patients are able to be transported to any destination hospital, not just Harborview. Airlift NW honors Lifeflight membership.
